RELEASE OF STUDENT INFORMATION – OPT OUT FORM

We make every reasonable effort to protect our students' privacy. For example, it is our policy not to release information to businesses for commercial purposes or to individuals without good reason. We DO NOT release unpublished or unlisted telephone numbers.

The Nine Mile Falls School District enjoys celebrating the achievements and activities of our students with the Nine Mile Falls community through publications such as school and district newsletters, web pages, social media pages, activity/athletic programs, school yearbooks, published honor rolls, and the news media (may include, but not limited to, interview with newspapers, television, and radio.) Group pictures where students are not easily recognized will continue to be published.
